## REPORT OF OFFICERS: SECRETARY-TREASURER:

## Financial Report:

Brother Noelke reported that the Sub-Chapter has \$251,704.22 in cash and investments as of October 31, 2024. There are 1,223 members with a loss of 60 members since the first of the year. Currently there are 169 members with payroll deductions to the AFSCME PEOPLE fund.

Motion by Brother Pendracki, properly supported by Sister Bauman, to accept the Treasurer report for November 2024 as presented. The motion carried.

Brother Noelke requested for an amendment to the budget to move \$900 from Printing to Postage to cover the cost of mailing the October meeting notice and increasing the budget for Contributions by \$1,000.

Motion by Brother Pendracki, properly supported by Brother Wadlin to amend the 2024-25 budget by moving \$1,000 from line-item Printing to line-item Postage and increasing the budget for Contributions by \$1,000. The motion carried

## REPORT, COMMENTS AND ANNOUNCEMENTS: (Presented by Brother Macdonald) Medical Insurance for Disability Retirees

Since 2010, AFSCME Council 25 and this Sub-Chapter have been challenging the Wayne County discontinuance of health care insurance for disability retirees. There have been three (3) arbitration hearings, numerous Wayne County Circuit Court decisions and two (2) Michigan Court of Appeals hearings. The arbitrator award for the last hearing held on June 13, 2024, is still pending. Notwithstanding, that, the arbitrator and the courts ruled against Wayne County each time and, once again, Wayne County has filed another appeal to the Michigan Supreme Court. Wayne County continues to appeal the first arbitrator's award that states, "The County violated the collective bargaining agreement when it made changes to healthcare benefits for newly approved duty and non-duty disability retirees. The County must rescind Administrative Personnel Order 1-2010 and make whole the duty or non-duty disability retiree who was improperly denied healthcare benefits after 2010 by virtue of the fact that they did not meet the age and service requirements for "normal" retirement."

As of now, AFSCME Council 25 and this Sub-Chapter are waiting on the latest arbitrator's award; and if the Michigan Supreme Court will accept the latest Wayne County appeal. There has been no change since the October report.

## Basic Life Insurance and Supplemental Life Insurance

The Sub-Chapter has just received a copy of the insurance certificates for the retiree basic life and supplemental life insurance policies with MetLife that were renewed by the Wayne County Commission at its October 17, 2024, meeting. The certificates of insurance apply to "retired employees n or after January 1, 1998, who were members of a bargaining unit at retirement excluding the Airport Authority. The coverage provides a basic life insurance benefit of \$5,000; and also, if applicable, a supplemental life insurance benefit maximized at \$11,500. The basic life insurance premiums are fully paid by Wayne County. The supplemental life insurance plan requires retirees to enroll and pay the full premium. For those seeking more information, please contact President Yee.

As a reminder, employees who retired prior to January 1, 1998, are included in a prepaid life insurance package at Prudential Life Insurance Company. This group does include airport retirees since there was no Airport Authority in 1998. The coverage amounts vary based on the provisions of the collective bargaining agreement under which the employee retired. The prepaid life insurance benefits arrange from \$4,000 to \$10,000.

# HEALTH CARE INSURANCE SETTLEMENT (STIPENDS) Prescription Co-Pay Settlement

The payments by Wayne County of non-Medicare eligible stipends appear to be consistent with the settlement agreement through the payment due November 1, 2024. Wayne County is providing monthly reports of stipend amounts transferred to MERS/Alerus.

The Sub-Chapter has one (1) open file with unique questions concerning retiree stipends. This file is expected to be resolved without a grievance being filed.

During past meetings, we have urged our members who are included in the Medicare eligible stipend program to use the MERS document "Wayne County Health Care Savings Program Reimbursement Claim" form "Recurring Expense" section (Page 2) to obtain health care cost reimbursement from the funds in their account at ALERUS. We continue to suggest that participants claim the combined amount of their Part B and Part D deduction from their monthly social security benefits. Any other health insurance type premiums should also be added to that amount. Until next year as discussed above was not significant.

During the due diligence process following Sub-Chapter 38 forcing Wayne County to change paying agents to MERS/ALERUS for this program, your representatives Ron Yee, Doug Wadlin, Richard Noelke, James Sockolosky and myself demanded that a provision be included in the plan documents requiring that forfeited funds be distributed to all participants. Forfeited funds are those balances attributed to deceased participants at MERS/ALERUS that are not claimed by the deceased beneficiary or the participant's estate after a thorough and stringent process. In order to accomplish this additional benefit to the Medicare eligible stipend program, it was changed to a "Health Care Savings Program" as required in the US Internal Revenue Code. AS a result, all participants in this program will have slightly over \$50.00 transferred into their MERS/ALERUS account on January 1, 2025. This amount has nothing to do with your stipend – it's separate and a one-time occurrence.

One of things to take away from this discussion is participants must keep their beneficiary designation current with MERS/ALERUS and your applicable retiree life insurance carrier by way of the Wayne County Benefits Administration Unit, 600 Griswold, 9<sup>th</sup> Flor (313) 224-5381. In addition, keep your beneficiary designation current for your retirement benefits and 401K and/or 457 benefits at the Wayne County Retirement System, 28 West Adams, (313) 224-5860. The beneficiary designation for each of these benefits is separate from the other.

Motion by Brother Pendracki, properly supported by Brother Grysko, to accept Brother Macdonald's report. The motion carried.
